## About the service

Birdston Care Home is located in Kirkintilloch area of East Dunbartonshire. It is an NHS Continuing Care Facility, which operates as a partnership agreement between NHSGGC and Pacific Care. The partnership has proven to be a long standing success for both residents and their families.

The aim of the service, in line with the Conditions of Registration:

"To provide a care service to a maximum of 63 adults, age 30 years of above, with mental health problems, including organic mental health disease and presenting with challenging behaviour. "

Birdston Care home can accommodate 63 residents in single ensuite bedrooms. The service is in a rural area, with other care home services within the local area.

Birdston Care Home is a specialist nursing home, within a purpose built unit. Residents have access to garden areas. The service provides care to older people including residents with a variety of mental health illness and many types of dementia.

The overall aim of the service is to provide care and support for residents within a safe environment.

The Care Inspectorate is currently awaiting clarification on its role and remit in relation to inspection of services which are considered to be NHS continuing care facilities. Until clarification has been obtained, the service will be inspected and regulated by the Care Inspectorate in line with its registration as a care home.

### What people told us

We spoke with ten residents and met with three family members/carers during the inspection visit.

We found that the NHS service continues to work in partnership with the Care Inspectorate to promote a safe and supportive environment.

At the time of the inspection we noted that 13 residents & carers met with the inspector from a total of 63 residents.

We spoke with residents and carers who were happy with the care service and found that residents and their carers/friends felt that they could take forward concerns.

The service has developed a cafe area where residents, their carers/friends could use, if they wish to do so.

We found that the service should continue to offer a range of activities appropriate to the support needs of residents.

## Self assessment

The service submitted its self assessment which provided some detail in relation to this care home as well as plans for the future NHS and partnership.

# Quality of care and support

#### Findings from the inspection

We wrote this report following an unannounced inspection which took place over a one day period.

We observed staff interaction with residents, their carers/friends and found that this was supportive, with residents, carers/friends and staff members interacting, we looked at:

- Observation of the environment
- Birdston Nursing home and Pacific Care Newsletter January 2016
- Care plan information for residents.

We sent Care Standards Questionnaires to the care home, with two completed questionnaires returned to the Care Inspectorate. Comments from questionnaires included:

"You may find it strange that I am this satisfied with my husband's care. I have very high standards myself and didn't want to have him go into care."

"I am delighted that his challenges are being met by a highly professional team who are sympathetic, incredibly hard working, good humoured and above all caring."

"A mature experienced staff who know that they are doing and who work seamlessly as a team."

"No one wants to go into care but the care here is the best it can be. Staff are great."

"A fantastic cleaning team working behind the scenes ensuring cleanliness in rooms and corridors."

"The food and the kitchen staff are just fantastic."

"My final word, we have the most fantastic hard working nursing/caring staff."

"I have peace of mind knowing how well cared for my husband is. All our family would be in agreement with this. As at times it is a meeting place for our family."

"We are very happy with the care and everyone has been so helpful."

"I also love the cafe, Susan, Elaine and Aiden make it special."

We found that the service provides a very good standard of care and support.

We spoke with members of the staff team as well as residents, their carers/friends and found that staff members supported residents in relation to the care and support provided. Residents were at ease in the company of staff and enjoyed chatting with staff as well as other residents., their carers/friends.

We observed the mealtime experience for residents and found that residents felt supported, with menu choices which residents could select, if they wished to do so.

We found that the service had recently promoted cafe sessions two days per week, which residents, their carers/ friends clearly enjoyed.

We looked at care plan information and found that staff members were aware of the support needs of residents. Residents were given choices in relation to menu planning and activities.

# Quality of environment

#### Findings from the inspection

We found that the service provides a very good standard of care and support.

We found that the service had promoted a suitable environment which supported residents to give their views and preferences.

The care home was clean and tidy with no offensive odours present during the inspection visit. We found that the service had a variety of sitting areas as well as enclosed outdoor space which residents, their carers/friends could use if they wished to do so.

The residents were at ease in the company of staff.

We found that residents had choices in relation to activities. This included therapets, games and newspapers.

We found that staff members promoted the use of the environment. This included a variety of sitting areas which residents could enjoy, if they wished to do so.

Residents are NHS patents who are referred to Birdston Nursing Home by the Consultant Psychiatrist responsible for their clinical care. Nursing and care staff, pharmacy, policies and procedures, training and some aspects of documentation, such as accident/incident reporting and care planning are provided by the NHS Trust.
